Homeowner, Dan Andrews, has agreed to fill the vacant Director's position.

The Orchards Commercial Property/General Liability and Directors and Officers Insurance policies have been renewed for 2016.

Federal income tax of \$1,564 was paid for the 2015 year. Our accountant, Jessica Wenger, CPA of Wenger & Company PC reported that the Association overpaid the 2015 federal income tax by \$385. She recommended again this year (2016) the Association do quarterly tax payments. The first quarterly payment will be \$365 with two quarterly payments of \$375 and the \$385 overpayment credited from prior year for a total of \$1,500 for 2016. This was necessary due to cash withdrawals from our Capital Reserve Investment accounts for the townhouse roof replacements and to avoid a penalty from the IRS.



Design Review

Please remember that a Design Review Request Form must be completed for any landscaping and architectural changes. All changes must be made in coordination with the Covenant and the Guidelines.

LAWN CARE

MOWING

Diamond Lawncare and Snow Removal will be doing the mowing for the Townhouses, Zero Lot, and Common Area of the Orchards. Diamond Lawncare started mowing the Townhouse, Zero Lot, and Common Area last week. They will be mowing each Thursday, weather permitting; otherwise they may mow on Wednesday or Friday.

Also, if there is dog waste in the grass, please make sure it is picked up before mowing begins. If items are not moved or if dog waste in the grass is not picked up your yard may not be mowed.

MULCHING

Mulching is not done by the Association and homeowners must contract with a supplier on an individual basis.
